China's New Foreign Investment Law

New winds of openness, coming from the mainland, are on the rise, as China's National People's Congress passed a new Foreign Investment Law, which will come into effect on January 1, 2020.

This new piece of legislation claims to be "liberalising and facilitating investment at a high level, establish(ing) and improv(ing) mechanisms for promoting foreign investment, and build(ing) a market environment of stability, transparency, predictability, and fair competition."

It may be a response to the growing international criticism about China's relation with international investors and may be a first step to start settling the US-China Trade War.

The new legislation will take the place of the three previous applicable laws, namely the Sino-Foreign Equity Joint Ventures Law, the Sino-Foreign Contractual Joint Ventures Law, and the Wholly Foreign-Owned Enterprises Law. It focuses on investment promotion protection and management, as well as in legal responsibility of the foreign investors.

Regarding investment promotion, this diploma starts by saying that the State's policies "equally apply to foreign-invested enterprises," and that the opinion of foreign-invested

enterprises will be taken in the formulation of laws, regulations or rules relating to foreign investment, and even that they will be invited in efforts to formulate standards.




