Macau is known for its multicultural environment, and many of us have either a friend, a colleague or know someone who has applied for Macau residency. When we talk about the application for a residence permit in Macau, the most talked-about issues are the concept of regular residence and the criteria of 183 days' stay in the MSAR. Both are considered by the authorities as essential requirements to support the decision to approve or reject the renewal of a residence permit that will pave the way to permanent residence.

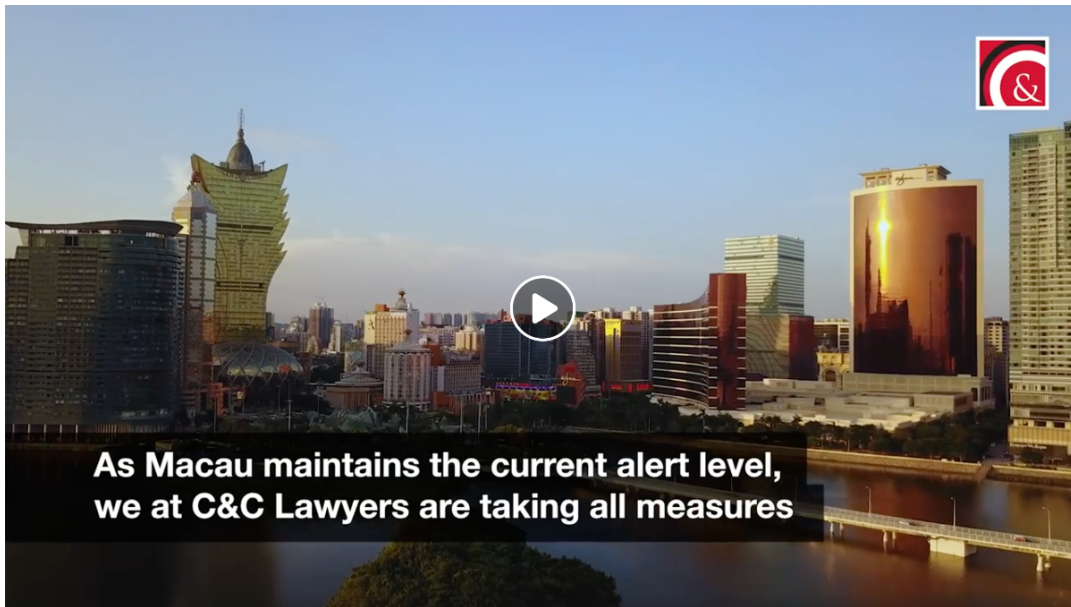
