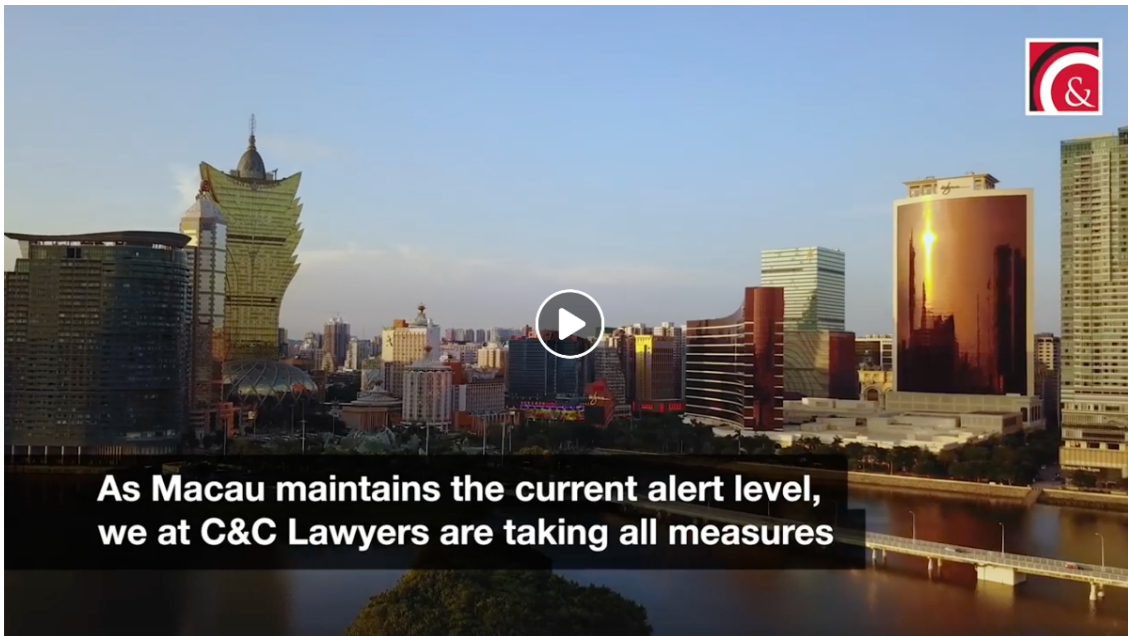

In Mainland China, the Data Security Law was recently passed on June 10th. Parallel to the GDPR, China has developed a new data protection legal framework (PIPL).
