## The Macau Trust Law

Macau is finally taking the last steps of a long legislative path to approve and implement a trust regime in Macau.

Generally approved by Macau Legislative Assembly, the new Trust Law provides for the respective legal regime, which was absent from Macau Laws, preventing the use of this legal figure, accepted in many jurisdictions worldwide by trustees, trustors and beneficiaries.

## Lei da Fidúcia de Macau

Macau está finalmente a dar os últimos passos de um longo percurso legislativo para aprovar e implementar o regime legal da fidúcia (trust) em Macau.

Aprovada na generalidade pela Assembleia Legislativa de Macau, a nova Lei da Fidúcia prevê o respetivo regime jurídico, que estava ausente, até agora, das Leis de Macau, impedindo a utilização desta figura jurídica, aceite em muitas jurisdições a nível mundial pelos fiduciantes, fiduciários e beneficiários.

仍處於立法程序中的《信託法》，旨在通過信託為財富管理提供合法安全網絡來滿足市場預期。其預見了信託資產的定義、設立和清盤，以及所有相關方（即受託人、委託人和受益人）的能力、權利和義務。

The Macau Consumer Rights and Interests Protection Law (Law 09/2021) was approved on June 24, 2021, and entered into force on January 1, 2022.


